

- PROVIDE NEW TRANSITION BETWEEN DISSIMILAR
 FLOORING MATERIAL. JOHNSONITE COLOR: 32 PEBBLE
- REMOVE EXISTING VCT. (APPROX. 80 S.F.)
- 4 RUBBER FLOOR TO REMAIN.
- REMOVE ALL DOOR STOPS FROM DOORS. FLOOR DOOR STOP WILL BE REMOVED BY OTHERS. SEE IMAGE 4/F.1. PROVIDE AND INSTALL NEW FLOOR DOOR STOP.

NOTE: MANUFACTURES LISTED ARE BASIS OF DESIGN

- CONTRACTOR TO PREPARE FLOORS TO RECEIVE NEW FLOORING AT AREAS WHERE NEW FLOORING IS PROPOSED
- 2. CONTRACTOR TO FIELD VERIFY EXISTING FLOOR
 CONDITIONS AND FLOOR LEVELS AND PROVIDE LEVELING,
 AND LEVEL TRANSITIONS AS REQUIRED FOR NEW FLOORING
 INSTALLATION. PROVIDE NEW TRANSITION STRIPS AS
 PROVIDED WHERE NEW FLOORING MEETS EXIST. FLOORING
- 3. ALL DOORS TO REMAIN VERIFY FLOOR CLEARANCE AND COORDINATE WITH TRANSITION STRIP COMPATABILITY.
- 4. ALL WORK SHALL BE EXECUTED IN COMPLIANCE WITH ALL APPLICABLE FEDERAL, STATE AND LOCAL CODES, LAWS, AND REGULATIONS. IF IN THE EVENT THAT HAZARDOUS MATERIAL HAS BEEN DISCOVERED ON SITE, STOP ALL WORK AND INFORM THE OWNER PRIOR TO ANY WORK MOVING FORWARD.
- 5. CONTRACTOR TO VERIFY ALL CONDITIONS AND DIMENSIONS AND REPORT ANY DISCREPANCIES TO THE OFFICE OF THE ARCHITECT IMMEDIATELY.
- 6. INSTALLATION OF FLOORING SHALL BE IN COMPLIANCE WITH MANUFACTURES SPECIFICATIONS.
- 7. AT ALL EXISTING CLASSROOM ENTRANCES THAT HAVE WOOD BASE, BASE WILL REMAIN AND WILL NOT RECEIVE NEW BASE. SEE IMAGE 3 ON SHEET F.1.
- 8. PROVIDE 6" RUBBER COVE WALL BASE AT ALL AREAS WHERE NEW FLOORING IS PROPOSED. JOHNSONITE, TSB-32-6, COLOR: 32 PEBBLE

INSTALLATION FOR RM. 24 ART: AUGUST 7TH - 8TH







