# TO THE BID SET AND SPECIFICATIONS FOR Rockford Public Schools - Water Service Removal

#### **CLARIFICATIONS**

#### Water Service Removals

The quantity of service removals has increased by two. Abandonment of the water services to 1610 Charles Street and  $1xxx \ 2^{nd}$  Avenue have been added to the scope of work.

## Pavement Removal and Replacement

Pavement removal and replacement for water service abandonment on the Vacated Street and 2<sup>nd</sup> Avenue shall be 10'x10' patch at each service location.

Pavement removal and replacement for water service abandonment on Charles Street shall be a full lane width from transverse joint to transverse joint (10.5' x 20').

## **Existing Water Main Sizes**

Existing water main size on Charles Street is 12". The existing water mains on 2<sup>nd</sup> Avenue and the Vacated Street are 6".

1. ALL WATER SERVICES SHALL BE FIELD VERIFIED FOR DEPTH AND LOCATION.

2. SAWCUT 10'x10' AREA FOR EACH WATER SERVICE CONNECTION LOCATED ON 2ND AVENUE AND THE VACATED STREET.

SAWCUT AND REMOVE FULL LANE WIDTH FROM TRANSVERSE JOINT TO TRANSVERSE JOINT (10.5'x20') FOR EACH WATER SERVICE LOCATED ON CHARLES STREET.

CORPORATION STOP SHALL BE TURNED OFF AT MAIN, WATER SERVICE LINE SHALL BE DISCONNECTED FROM MAIN, CAPPED, AND ABANDONED IN PLACE. EXISTING CURB BOXES SHALL BE REMOVED.

5. CONCRETE REPLACEMENT SHALL BE DOWELED TO EXISTING PAVEMENT
