# **B. Lincoln Middle School**

- 14. Paint wire mold and conduit to match wall color on walls to be painted.
- 15. Paint existing blue door and frame and wood base in Entry "K" PT-6.
- 16. Change Key Note 7 on Painting Plans from PT-6 to PT-3.
- 17. In Stairwells on south side of Gymnasium, do not paint wood doors or wood door frames.
- 18. Paint hollow metal doors and frames in corridors on 1st, 2nd and 3rd floors PT-5.
- 19. Paint hollow metal doors and frames between corridor and vestibule at Entry "N" PT-5.

# C. Summerdale Early Childhood Center

- 20. Install 6" rubber base in Conference Room.
- 21. Do not paint upper ACT panels on walls with window coverings in classrooms that run parallel with corridor.
