

PRE-BID MEETING CLARIFICATIONS AND QUESTIONS

- 1) Where is the Bituminous Paving that is referenced in the Specifications? Bituminous paving is only included as a POTENTIAL for patching MAY exist. IF the existing bitum, paving can be cut and is undamaged at the end of the project no paving work will be required.
- 2) What are the Specific Requirements For All Hardware and Keying Per District Per the drawings, keyway for all doors to be Sargent LL with blank cylinders and (2) blank keys.
- 3) Is the floor to match the grade at the parking? Site plan, attached, was provided to the attendees. The building will have to be staked. The final finish floor will have to be field approved by the Architect and RPS205. It is ANTICIPATED that grade will be 882.6'. Final finished floor to be a minimum of 4" above grade at nearest point.
- 4) Clarify the option for the footings. BOTH footing options require the turned-down slab edge! The option is for the footing at posts. Contractor may auger and pour a 12" thick, 24" dia. footing as shown on Detail 7. OR the contractor may auger and place a solid patio block, bear the column on the block and fill the entire 24" dia. hole encapsulating the column in concrete.
- 5) Clarify building intent. Drawings were prepared to allow for EITHER a purchased and erected pole barn kit, OR the construction of individual assembled components. Signed/sealed Truss Drawings ARE required. IF posts are laminated lumber information must be provided to show they are equal to a solid 6x6 post.
- 6) All questions concerning the project need to be directed to Purchasing (see attached sheet).
