### 14. Superintendent's Report

A. Superintendent's Report – Dr. Jarrett

Dr. Jarrett gave a brief update before ceding his time to Ms. Slotten-Beauchamp. He spoke of "Those Who Excel" banquet, and recognition given to Board President Mr. Scrivano. He acknowledged the Golden Apple Award winners and looks to forward to recognizing them at the upcoming banquet. In addition, on April 26, 2019, Rockford Promise will be awarding thirty-one full scholarships to District students.

B. Nutrition Services Update – Renee Slotten-Beauchamp – Executive Director of Nutrition Services Ms. Slotten-Beauchamp gave a presentation for Nutrition Services. A three-year plan was presented in 2017 and the department is restructured. The focus this year began with setting aggressive goals. The first goal was supplies and food costs. Nutrition Services is part of a national food-buying group, HPS. The department moved from using two distributors to one. Substantial savings were realized, approximately \$550,000. Ms. Slotten-Beauchamp is working with HPS for a better pricing with supplies. The second goal is to increase breakfast participation. The goal is forty percent, and currently the District is at thirty four percent. The department also examined percentage of lunches served, and the goal is seventy-eight percent participation, with current participation rate of eighty-two percent. Salad bars are now implemented at a few schools. The department also focused on improving employee skill level. Field and staff supervisors have worked with staff for better service, food presentation, and quality. Trends include quality food/branding, made to order, clean-labeled products, Grab n Go/Bento meals, diversified menus, and mini products.
