## **GENERAL ITEM**

#### 1. QUESTION #1

1.1. "At the Prebid meeting and followed up in Add #1, the mounting surface for shades was to be to the existing exposed wood at the window head UNLESS asbestos ceiling tile was at the window head, then we were to attach to the face of the window mullion.

If ceiling tile is at the window head, but does NOT contain asbestos, do we still attach to the face of the window mullions for a more secure attachment?"

#### 2. ANSWER #1

2.1. Answer is yes if there is ceiling tile or a steel lintel then the window shades are to be mounted to the window mullions, keeping the same installation contestant with in each room.
