## 4. 122413 - ROLLER WINDOW SHADES

**4.1.** Page 122413-3, par. 2.1. A: Add as an approved roller shade manufacturer: Draper XD Clutch Flexshade with Phifer 4800 and 2700 Sheer Weave Fabric.

## 5. HASKELL - DRAWING A107

**5.1.** At window types W3, W5, W6 and W8: Change the mullion dimensions to be centered in the frame per the insulation added to details J3 and J5.

#### 6. HASKELL - DRAWING A108

**6.1.** At details H1, H4, J1 and J6: Change the solid surface material to new stained and sealed oak hardwood. The solid surface stools and aprons remain at details S1, S4 and S5.

**8.1.** At window types W3, W4, W5, W6, W7, W8, W9, W10, W13, W15, W18, W19, W20 and W21: Change the mullion dimensions to be centered in the frame per the insulation added to detail J3.

## 9. SUMMERDALE - DRAWING A109






