CLARIFICATIONS

1. Sheet 4 - Removal Plan

- A. The 4 bollards around the fire hydrant in parking lot are to be removed and replaced in same position during construction.
- B. Added General Note Existing underground electrical wires need to be protected and if disturbed replaced by contractor at no additional cost

2. <u>Sheet 6 - Striping Plan</u>

A. Striping plan has been revised and now includes both SBLS - 4" and SYLS - 4" pavement markings

3. Sheet 7 - Bituminous Pavement Cross Sections

A. Base course was labeled "... CA-2 Open Graded" and should have been labeled just "...CA-2". The words "Open Graded" have been removed.


