11. Superintendent's Report

- B. School Scorecard Presentation

Dr. Jarrett presented the School Scorecard to members. This is to lay out the strategy of the District. The embargo ends October 31/November 1 and at that time Administration will see how schools performed. The District's goal is to improve all schools and ensure all students have access to a high-quality school. The District's 2019-2020 MAP and IAR, PSAT and SAT are integrated. Conversation includes growth and attainment, and more emphasis on climate and culture. The score card will have one clear measure of school success.

Dr. Vosberg continued with the presentation. The Administration will provide a goal setting framework for all schools. All principal meetings will continue on a monthly basis, including leveled principal meetings, elementary and secondary. Measurements are on a four (4) point scale; 3.0 for Quality Instruction, 1.0 Climate & Culture. Quality Instruction metrics include Early Childhood, Kindergarten through 8th grade, and high school Climate & Culture metrics are Kindergarten through 12th grade.

The next steps include Scorecard Overview 10/23/19, public data release 10/31/19, and a complete report at the November 5, 2019 Committee of the Whole meeting. To view the presentation, please click on this link: School Scorecard.

A. Academic Approach – Essay Assessment.

Currently, District students take the essay test of the SAT exam in the spring semester of their junior year in addition to the ERW and Math test. To practice and establish growth metrics for the ERW and Math tests, the District administers the PSAT twice annually for all 9th and 10th graders. However, the PSAT does not include an essay test. District results demonstrate a need for additional practice and data-driven instructional supports for students well before they take the essay test for accountability in the spring semester of their junior year. The Administration recommends an essay scoring service through Academic Approach. This will provide students and teacher opportunities to track data

aligned with District goal for writing performance. The fiscal impact is \$40,560. To view the information, please click on this link: <u>Academic Approach</u>.
