CLARIFICATIONS

Below are requests for information to date and corresponding answers.

- 1. Page 38 of 40, RFP OFFER FORM: When referring to "unit cost", Edustaff would normally interpret this as the calculated daily billing rate (in dollars) for a district. However, this form only asks for the unit of measure in percentage. Are we correct in only listing the percentage daily rate increase on this form? We just want to ensure we have the correct information listed.
 - a. Yes, the pricing should be submitted as a percentage applied to our daily rates.
- 2. Will the questions and answers from all parties be shared back with all parties?
 - a. Yes, all questions submitted since Addendum One are included in this addendum.
- 3. What is the purpose of the certified employee list? (Optional) Page 31?
 - a. Any third-party contractor who does work on District property must pass the background checks referenced on this document. If your proposal does not require anyone from your company to be on District property for installation, training, or support/maintenance of the equipment this form can be submitted as "non-applicable".
- 4. The "Evaluation Criteria" (page 40) is dated December 15, 2022 is this just a standard RFP document?
 - a. We adjusted the RFP timeline after that document was created. Included in this addendum is a revised version with the correct due date of January 5, 2023.
- 5. RFP 23-24 Substitute Management ADDENDUM NO. 1: The Paraprofessional rates are listed as Daily rates (Mirroring Educators). Per IL Wage and Hour Compliance, these positions are typically paid as hourly. Does RPS intend to pay these positions on a per diem rate?
 - a. RPS pays these rates on an hourly basis. Included in this addendum is a revised chart of Sub Pay Rates.
