PRE-BID MEETING

1. What was the bid summary of the last bid and what is the current pricing?
Current costs consist of fixed monthly (\$3,294.48) plus variable extra site visit costs incurred when work orders are issued for pest control. The extra costs have amounted to approximately \$45K annually.
2. Can you provide a square footage list for all buildings?
A spreadsheet with building square footage is being distributed to all attendees. The spreadsheet is also attached.
3. What is the current schedule of services?
All buildings are serviced twice per month.
4. Do any schools have any issues with bed bugs?
None of our schools presently require bed bug treatment. In the past year, we treated approximately 20 classrooms.
5. What specific services do you accept work orders for?
Work orders are generated for ants, cockroaches, mice and other common pests.
6. What type of work orders are generated regarding pests? What type of pests?
See answer to question # 5.
7. Do the schools have rat problems?
No
8. What type of treatment can be used for bed bugs?
Recent treatment has involved Cimexa. Other treatments will be considered provided they are safe, effective and approved for use.
9. Can the requested hourly cost for bed bug treatment be changed to per classroom cost?
No, the District is requesting an hourly rate for bed bug treatment.
