IESA Cheer

Rockford Public Schools had two middle school compete in the IESA State Cheer Tournament - Eisenhower and Lincoln! Lincoln Middle School's cheer team finished in third place at the IESA State Cheer Tournament - Small Cheer Division – with a score of 77.40. The team trailed the second-place team by 0.08 points! (77.48). Eisenhower Middle School's cheer team also competed at state in the Small Team Routine. Congratulations!

IHSA Wrestling

Two students from East High School gualified this year for the IHSA State Wrestling meet. Senior Eh Ta Sor finished fourth in the IHSA Class 3A Barrington sectional tournament in the 113-pound weight class to earn a ticket to state. Sophomore Joey Pineda finished second in the sectional at 285 pounds to gualify for the state meet. Joey and Eh Ta Sor both lost in their first round, but Joey advanced to the second and third round of wrestlebacks, ultimately losing to the third-ranked wrestler in the state in his weight class. Congratulations to both young men on an outstanding season!

Poetry Out Loud

Two Jefferson High School students gualified for the state Poetry Out Loud competition in Springfield last month. Jada Cox and Nada Abdulaziz were among more than 10,000 students from 43 schools competing. There are eight regions in the state, and only the top 16 students make it to the finals. Jada Cox was a top-five finisher with "Mothering Blackness" by Maya Angelou and "I Felt a Funeral in my Brain" by Emily Dickenson. Nada Abdulaziz competed with "Epitaph" by Katherine Philips and "Diameter" by Michelle Y. Burke. Congratulations to these outstanding students! **IHSA State Speech**

Jefferson High School senior Jada Cox and Auburn High School senior Aryan Arora competed last month in the IHSA state speech tournament in Peoria. Jada competed in the poetry reading category, sharing "The Autobiography of an Empire." She finished third in the Freeport sectional to qualify for the state meet. Aryan competed in the impromptu speaking category and finished second at sectionals.

At the state tournament, Aryan made history for Auburn and RPS 205. He brought the first state speech title back to RPS 205 in 57 years, and he is the seventh RPS 205 winner ever in the IHSA speech competition.

Aryan recently shared his story in a blog post on the 205 VIBE and shared a lot of thanks to his coaches, teammates, administrators and teachers, and his family for supporting him during the speech season. "But most importantly," he wrote, "to my community that has taught me the importance of my voice. Behind every individual events champion, there is an army of people who fought to make their achievements possible. I didn't win a state championship. We did."

B. Health Insurance Update

Ms. Inez Harris, Senior Benefits Manager, presented the update to Board members. The historical summary was presented with FY2019 costs 12.99% higher than in 2011. The average increase over the past eight years is approximately 1.62%. The average medical inflation during the same time period is approximately 6%. FY2020 costs are currently running at \$15,981, Per Employee Per Year (PEPY) which is 10.3% higher than the previous year. The District's trend versus actual has been lower. Factors contributing to the lower cost trend include improved Rx rebates, lower overall utilization, coverage management programs with Express Scripts, Wellness Plans, and added active health disease management program. Potential causes for increased cross are only minor plan changes this year to offset trend, increased cost of specialty medications, and potential for an increase in large claims next year. Cost saving initiatives are continued wellness initiatives, pharmacy management programs, continue virtual visits through Tel-a-Doc, and Rx contract renewed with improved discounts from average wholesale price and better rebates.
