PRE-BID MEETING

- 1) Sandro Ignjatovic with RPS205 started the meeting at 10:04am. Three (3) bidders were present, including Sandro and myself.
- 2) A sign-in sheet was passed.
- 3) Sandro read the Opening Statement and provided each bidder a written copy. Belles emphasized: That it was important to allow enough time to deliver bids, as it requires getting thru security; To properly fill out ALL forms; and that today was the only opportunity for the bidders to ask questions directly to the Architect.
- 4) Sandro asked if there were any questions.
- 5) Is Old Castle an acceptable storefront manufacturer (not listed specifically in the specs). **YES.**
- 6) Does the district want Laminated glass on the interior panes of glass as in prior work? YES. Provide tempered at exterior face and laminated at interior face of all exterior doors and glazed openings. Rob noted the reception window did require "security glass" which could be laminated.
- 7) Sandro noted it was desired that work at the front office be done June 16 thru Aug 16 when the office staff was off.
- 9) All parties walked the perimeter of the building and went over work at each opening, as well as an overview of the masonry repairs.
- 10) Meeting was adjourned at 10:37am.
